## SURRENDER AGREEMENT

The following binding legal agreement between AZ Pug Life Rescue Society (“AZ Pug Life Rescue”, “APLRS”, “we”) an Arizona non-profit organization, and you, \_\_\_\_\_ herein referred to as “you” or “owner” attest and confirm the information given regarding age, temperament and condition of the dog is complete and accurate to the best of my knowledge.

\_\_\_\_\_ You have full power and authority to surrender this dog for adoption, that you are the only person(s) are listed as registered owner(s) of this animal and the no other person or persons have any legal or equitable ownership interest in this animal.

\_\_\_\_\_ You understand by executing this document you are surrendering all right, title and interest to the dog and further understand that all future decisions regarding the placement of this animal will be made solely by APLRS. You also understand that if this dog is later found to have such an unpredictable temperament as to be unsuitable for any placement, or if the animal's quality of life is substantially impaired in the opinion of a competent veterinarian, by a chronic, irreversible, painful condition euthanasia may be considered as a final alternative to adoptive placement as a last resort.

\_\_\_\_\_ You understand that we have the right to return this dog within 48 hours to you the owner for undisclosed medical or behavioral issues.

\_\_\_\_\_ You, the undersigned, hereby specifically and forever release, and hold harmless APLRS, from any and all liability arising from the placement for adoption or for any other actions taken by APLRS in accordance with, and in reliance on, the representations we have made, and the authorizations we have provided under the terms of this document. You agree to indemnify and hold harmless APLRS for any damages suffered and expenses incurred, including legal fee, in defending any legal action, whether for bodily injuries or death, property damage, breach of contract or otherwise, whether instituted by us or by any other person or persons including the adoptive owners, arising out of or in consequence of the placement of the dog.

\_\_\_\_\_ If any term of this Agreement is to any extent invalid, illegal, or incapable of being enforced, such term shall be excluded to the extent of such invalidity, illegality, or unenforceability; all other terms hereof shall remain in full force and effect.
